

Significant Event Notice

Diversa Trustees Limited, as the Trustee of YellowBrickRoad Super and YellowBrickRoad Pension (YellowBrickRoad or the Fund), a sub plan of MAP Superannuation Plan, is writing to advise you of some important changes to the fees and costs you pay as a member of the Fund from 1 November 2019.

New fee structure

We are introducing a new fee structure, which is simpler and easier to understand.

The new fee structure is effective 1 November 2019 and consists of the following changes:

- An Account Keeping fee of \$150 applies if you invest in the CORE menu, which includes Pooled Investment Options, FUND.eXchange Managed Funds, Cash Hub and Term Deposit Hub, calculated daily and deducted from your Cash Hub monthly and on exit,
- An Account Keeping fee of \$250 applies on all assets that form part of the FULL menu (defined as all assets), calculated daily and deducted from your Cash Hub monthly and on exit,
- Administration fee will now be charged on your total account balance, including your investments in the Cash Hub, Term Deposits, FUND.eXchange Managed Funds and Pooled Investment Options,
- Removal of Transaction fees on individual Managed Funds, FUND.eXchange Managed Funds and Term Deposits,
- Removal of the Exit fee (from 1 July 2019),
- New Expense Recovery fee of 0.03% + \$50 on all balances,
- Removal of the Member and Trustee fee, and
- Removal of the Minimum Administration fee.

A full list of the fee changes is attached at the end of this notice. Please note that these changes will result in changes to your fees, and in some cases may result in an increase. We strongly recommend that you ensure you understand the impact on your account. Please contact your financial adviser to discuss this change.

A new Product Disclosure Statement will be issued to reflect these changes and will be available via the Secure Online Portal from 1 November 2019.
