## **Collection and Disclosure Statement**

In this Collection and Disclosure Statement:

**Money Masters Portfolio** means the model portfolio offered by OneVue Wealth Services as part of the OneVue Managed Account (registered management investment scheme ARSN 112 517 656) and managed by Mercer Investments (Australia) Limited ABN 66 008 612 397 (AFSL 244385) as Investment Manager.

**NMPE** means No More Practice Education Pty Ltd ABN 44 615 591 949 Authorised Representative No. 001263352, an authorised representative of OneVue Wealth Services and a member of the OneVue Group.

**Online Application Form** means the online application form provided via the Website by which You (if eligible) may make an application to invest in the Product(s) You have chosen.

**OneVue Fund Services** means OneVue Fund Services Pty Limited ABN 18 107 333 308, a member of the OneVue Group and a provider of unit registry services.

**OneVue Group** means OneVue Holdings Limited ACN 108 221 870 and its direct and indirect subsidiaries including NMPE, OneVue Fund Services and OneVue Wealth Services.

**OneVue Wealth Services** means OneVue Wealth Services Ltd ABN 70 120 380 627 AFSL 308868, a member of the OneVue Group and responsible entity of OneVue Managed Account.

Person means a natural person (or natural persons in the case of a joint application) or a trustee of an SMSF.

## **Collection, Use and Disclosure**

Your Personal Information is being collected by OneVue Wealth Services and/or OneVue Fund Services (**we, our, us**) which are both members of the OneVue Group.

The information we collect will include certain identification information about You as required by the Anti-Money Laundering and Counter Terrorism Financing Act 2006 (Cth) and Anti-Money Laundering and Counter-Terrorism Financing Rules Instrument 2007. We may disclose Your Personal Information to our related bodies corporate, the Responsible Entities and investment managers for Your selected Products and other contractors or service providers. In some circumstances we will disclose Your Personal Information to contractors or third parties outside of Australia.

We may request a credit reporting agency to provide an assessment of whether you/your director's details matches (in whole or part) personal information held by the credit reporting agency. The credit reporting agency may prepare and provide us with such an assessment, which may include using your/each director's personal information, and personal information held by the credit reporting agency that is the names, residential addresses and dates of birth of other individuals.
