Your super contribution bank account details are changing

Please notify your payroll or whoever pays your super contributions as soon as possible, but by no later than 31 July 2020.

If superannuation contributions are sent to the current bank account after 31 July 2020, the funds could be significantly delayed in reaching your account.

Please do not transfer or deposit contributions into the new account stated above <u>prior</u> to 31 July 2020. The new bank account cannot be accessed and will not be monitored before this date.
